In exercise of powers conferred under Paragraph 1.03 of the Foreign Trade Policy 2015-2020, as amended from time to time, the Director General of Foreign Trade makes the following amendments in **Standard Input output Norms (SION), Appendix-4B and Appendix 4J** of Hand Book of Procedures 2015-2020:

1. The following Standard Input output Norms (SIONs) pertains to Food Products Group is suspended with immediate effect:

E75, E76, E77, E78, E100, E101, E102

2. Appendix-4B is amended to read as per Annexure attached to this Public Notice.
3. Existing entry at SI.No-7 of Appendix-4J is corrected to read as under:

7	Precious Metal Gold/Silver/Platinum (pertains to Gem and Jewellery Sector)	120 days

Effect of this Public Notice:-

- (i) SION SI.Nos E75, E76, E77, E78, E100, E101 and E102 are suspended with immediate effect. No Advance Authorisations shall be issued under these SIONs.
- (ii) Revised List of Nominated Agencies for import of Gold and Silver is published.
- (iii) Appendix 4J is amended restoring normal export obligation period for import of precious Metal for other than Gems and Jewellery sector.
